**RDC XI Resolution No. 4, Series of 2025**

**ADOPTING THE UPDATED RDC XI COMPOSITION AND APPROVING THE PROPOSED ALLOCATION OF PSR SECTOR SLOTS FOR THE TERM 2025-2028**

**WHEREAS**, Executive Order No. 82, Series of 2025, titled "RECONSTITUTING THE REGIONAL DEVELOPMENT COUNCILS," was issued by the President of the Republic of the Philippines on January 28, 2025, mandating the RDCs to serve as the primary institution for planning, monitoring, and coordinating development efforts in the region;

**WHEREAS**, the said EO provides for the updated composition and functions of the RDCs where it shall be composed of local government officials, selected regional heads of departments and other government agencies, and Private Sector Representatives (PSRs);

**WHEREAS**, EO 82, further provides that the RDCs shall select the PSRs from various sectors of society, including Non-government Organizations (NGOs), that would comprise one-fourth of the regular membership;

**WHEREAS**, during its CY 2025 2<sup>nd</sup> Quarter meeting, the Council agreed to adopt the updated RDC XI regular member composition pursuant to Executive Order No. 82, series of 2025 and likewise affirmed the retention of the Presidential Management Staff as regular member agency pursuant to Administrative Order No. 231 issued in 2008 (Annex A);

**WHEREAS**, the RDC XI members, have likewise agreed that the PSR slots be allocated in the following sectors, viz:

1. Labor	9. Urban Poor/Consumer Group
2. Infrastructure	10. Mining
3. Agriculture	11. Academe
4. Energy	12. Safety, Security and Disaster Resiliency
5. Indigenous Peoples	13. Tourism and Hospitality
6. Environment and Natural Resources	14. Logistics
7. PWDs/Senior Citizens	15. Health
8. Youth/Women/Children	16. Information and Communication Technology

**NOW, THEREFORE, BE IT RESOLVED**, that this Council adopt the updated RDC XI composition and approve the proposed allocation of PSR sector slots for the term 2025-2028.
